Nursery Admissions Policy

Introduction

The Local Governing Body is responsible for Nursery admissions. We are able to admit up to 15 children for morning Nursery and a further 15 children for afternoon Nursery. For eligible families, we also offer 30 hours Nursery provision; this is for a maximum of 24 children.

Admission Information and Procedures

Children can be admitted from the day of their third birthday, providing a place has been offered and is available. We try to meet parents' request for either a morning, afternoon or 30 hours place but can only do so if places are available. If places are limited, the Local Governing Body may not be able to offer your choice preference. The final decision on when a child is admitted and the allocation of sessions rests with the Headteacher and Local Governing Body of the school. **It is extremely important to note that admission to our school Nursery does not guarantee a subsequent place in Foundation Stage 2 (Reception class).**

We offer three types of provision in Nursery:

- Full-time: daily - 8.45am to 3.30pm (30 hours per week)
- Part-time: daily – 8.45am to 11.45am (15 hours per week)
- Part-time: daily – 12.30pm to 3.30pm (15 hours per week)

Parents wishing for their child to attend Nursery should contact the school when their child is two years old or as soon as possible after that. An application form should be completed and returned to school with the relevant supporting documentation (birth certificate and, if applicable, their Baptism certificate) at least one term before they are eligible to start Nursery. At this stage, parents must also provide evidence to confirm the number of hours to which they are entitled (15 hours or 30 hours per week).

Once the application has been received and processed, the school will:

- Inform parents whether or not a place has been offered;
- Arrange for an informal meeting to be held to discuss admission particulars, for example, an agreed start date, information about likes/dislikes, interests, allergies, developmental concerns etc.
- Arrange for an introductory visit to the Nursery to be made where the child is accompanied by parents. Following this, it is likely that the initial visits will be short – for example an hour; these will gradually increase one the child settles and becomes more confident and independent when moving around the unit.

If a place is not available following receipt of an application, this will be added to the waiting list and a place will be offered as soon as it becomes available.

Admissions Criteria

In the event there are more applications for places than the number of places available, places will be offered in accordance to the Admissions Criteria outlined below:

1. Catholic looked after or previously looked after children including those children who appear to have been in state care outside of England and ceased to be in state care as a result of being adopted.
2. Catholic children living in the parish(es) served by the school.
3. Catholic children living outside the parish(es) served by the school.
4. Other looked after or previously looked after children including those children who appear to have been in state care outside of England and ceased to be in state care as a result of being adopted.
5. Catechumens, Candidates and members of Eastern Christian Churches.
6. Children of other Christian denominations whose membership is evidenced by a minister of religion.
7. Children of other faiths whose membership is evidenced by a religious leader.
8. Any other children not within categories 1-7.

First priority within the individual criteria will be given to applications for children who will have siblings attending the school in years Reception to Year 6 at the proposed time of admission. It is important to note that parents/carers do not have a statutory right to an independent appeals panel if a place is not offered; however, any concerns can be referred to the Local Governing Body.

30 Hours Childcare Entitlement: Lunch Time Provision

There is a daily charge for lunch time care provision of £4.00 per day; £20.00 per week. This is to cover the cost of the practitioners who will be responsible for your child's care and supervision and is paid in advance. Due to the school having a commitment to employing the additional members of staff, unfortunately, if your child is ill or unable to attend nursery, you will still be charged for the missing days as part of the agreement. This payment is made via our Arbor payment system.

Wrap Around Care Provision

Our wrap around care provision (term time only) is provided by an external organisation, The Lime Trees. They provide a flexible service where parents can book the sessions that work best for them, using the online booking system located on their website www.thelimetrees.co.uk. Timings and costings for wrap around care are as below:
